The Family Educational Rights and Privacy Act (FERPA) allows the release of *directory information* without a student's permission or written release. See: <u>https://academic.uthsc.edu/policy_docs/FERPA-student-notice.php</u>. FERPA also provides University of Tennessee Health Science Center (UTHSC) students the option of restricting the release of directory information without the student's written consent.

UTHSC directory information includes not only such items as your name, classification, college, and university email, but also <u>any and all</u> *photographic, video, electronic images, and/or voices* of students' maintained by the University of Tennessee (UT) or UTHSC. As such and unless a student provides a *written* request to the Registrar to restrict directory information, the UT/UTHSC may include student's directory information in *newsletters*, yearbooks, class composites, commencement/graduation programs, articles, news releases, brochures, and other promotional items, communications, or marketing materials.

Students who restrict the use of directory information <u>are NOT included</u> in *class composites, the yearbook, and commencement/graduation programs,* and other UTHSC marketing and communication materials. However, we have found that students who restrict the use of directory information may wish to be included in certain UTHSC communications, publications, and marketing materials. We are, therefore, asking you to complete this form to self-select and provide permission for your directory information to be included in the class composite, yearbook, commencement/graduation programs, and/or communications, publications, and marketing materials.
