







### Requesting a Transcript of USMLE Scores

To obtain your USMLE transcript or have it sent to a third party, you must contact the ECFMG, FSMB, or NBME and pay the associated fee. Which entity you contact depends on which Steps you have taken and where you want your transcript sent. Use the table below to determine which entity you should contact based on your specific details and needs.

Step(s)/Component(s) Taken	Recipient of Transcript	Contact
One or more USMLE Steps	Medical licensing authority	<a href="#">FSMB</a>
All three USMLE Steps; or Step 1 and Step 2 CK and CS (if required), only when registered for or after taking Step 3	Any recipient	<a href="#">FSMB</a> 
Step 1 and/or Step 2 CK and/or CS only, registered by ECFMG	Any recipient other than a medical licensing authority	<a href="#">ECFMG</a>
Step 1 and/or Step 2 CK and/or CS only, registered by NBME	Any recipient other than a medical licensing authority	<a href="#">NBME</a>

- The fee - per transcript order - is \$70.00 for up to five recipients and \$5.00 for each additional recipient added at that time, on that order. All recipients must be included on the same order to take advantage of the \$5 pricing for additional transcripts.
- Make sure you have entered all recipients and have entered the correct recipients before making payment and submitting your order.
- FSMB provides official USMLE, SPEX, and FLEX transcripts only in an electronic (PDF) format. We do not mail paper transcripts.
