2:05 pm	Campus Safety Committee – Tim Barton
	Tim Barton is the Chief Safety Officer. The Campus Safety Committee was created
	over a year ago. There are representatives from each college and major departments
	as well as each of the Campuses (Nashville, Knoxville (covered by UTK safety
	committee), Chattanooga). The Campus safety committee serves the same role as the
	Employees Relations Committee. There is a representatives list available. You can
	obtain the list from Tim Barton or it will be on the Employee Relations channel on
	Teams. Any safety concerns you can report it to your representative or Tim Barton.
	Safety concerns can be emailed as well to <u>labsafety@uthsc.edu</u> . There are two safety
	departments on campus but they are ran by the same people. The two departments
	are Campus Safety and Emergency Management and the Office of Research Safety
	Affairs. Terri from the College Health Profession had a question concerning whom



the Campus Safety representative for the Speech Pathology for UTK. Tim advised Speech Pathology could reach out the Health Science Center Safety Committee. Peggy Reiser from Communications called attention to the representative list needs to be updated since some of the representatives have left the University. Dr. Bruce Shack (UTC), Dr. Chisholm-Burns, and the Faculty Senate. Dr. Kathy Kenwright from Health Professions will be retiring in June. Safety Committee meets quarterly. One of the agenda items for the upcoming meeting is the Exposure Control Plan. Needle Stick is the most common injured reported. ## 2:23pm Round Table Updates

- **Kristi Norman:** Next Tuesday the UT Presidents Awards Nomination information will go out to go out to all faculty and staff. UT System selects the winners, which will consist of a faculty and staff winner in each category. The criteria for the President Awards are the Be One UT Values. This year we will be able to nominate faculty and staff for each category. Ultimately, Chancellor Buckley will review and send 14 candidates for the rewards. On the President Awards form, there is a place for you to express why the faculty or staff members you recommend should be recognized. If they are nominated the nominee will have to get three recommendation letters. IPE Day is March 3<sup>rd.</sup> Volunteers needed for the poverty stimulation.
- **Peggy Reisser:** Would like to give a report on three or four stories from UTHSC News Site (news.uthsc.edu). Our Two top leaders Dr. Kennard Brown and Chancellor Buckley is in the Power 100 in the Business Journal. The Black student association honored their award 7 winners of 2023. - **Elaine Robinson:** Administration Constituents had questions concerning the hybrid schedule as well as will the 5 percent raise cause insurance to increase. Departmental wise Siham Sherif was one of the seven students honored as Black Student Association as outstanding student leaders. There is a question concerning the retirement parties for Drs. Brown and Tony Ferrara.

(Debbie)There will be at least two or three parties for Dr. Brown to allow an opportunity for everyone come wish him well on his next endeavors and



congratulate him. The five percent raise is not tied to our insurance so it will not affect it. The five percent was proposed but not yet approved.

(Olivia) The five percent raise proposed and not approved yet. It has to be voted on by the state. If it is approved, it goes into effect on the August or September paychecks. There are no changes regarding Hybrid schedules, working remotely and working in person. It has been left up to the departments to evaluate the position and determine if the position can be hybrid, in person or fully remote. The staff or faculty will have to demonstrate the performance level or at least maintain good performance to become hybrid or work remotely. Documentation can be submitted to HR for review. In surveys it shows work life balance is essential. Chancellor Buckley loves the feeling of campus events being full. It is advised when live events occur to encourage high participation so hybrid and remote work can stay.
